Allegation: Must obtain any insurance required by federal law including but not limited to maritime insurance

Action: Found guilty by the Board. Fined and assessed all costs associated with the proceedings. The Board issued a Cease and Desist order. The Board requested the case to be submitted to the Attorney General's office and the Louisiana Workforce Commission.
