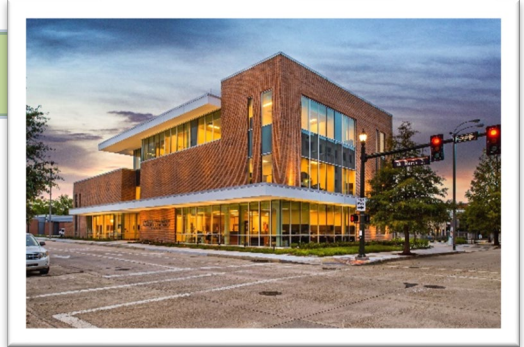

Classification Description

Refers to the installation, maintenance or repair of all types of swimming pools, whirl pools, hot tubs, water features and fountains, and all associated components.

Introduction



Swimming Pools is a *closed book* examination with 50 multiple-choice questions and a minimum passing score of 70. You will have **two hours** to complete this examination.
