Mr. Fine led the Pledge of Allegiance.

Judge Darrell White gave the invocation.

Mr. Wyman made a motion to accept the Minutes of the August 15, 2018, Residential Building Subcommittee Meeting. Mr. Morse seconded. The motion passed.

Mr. Hassert introduced guest Alicia Wheeler with the Louisiana Attorney General’s Office.

**NEW BUSINESS**

Leann Evans with the Compliance Department, Elaine Riggins with the Applications Department and Brad Hassert with the Compliance Department for the board were sworn in.

**C. INSURANCE HEARINGS:**

**RESIDENTIAL BUILDING, HOME IMPROVEMENT, AND MOLD REMEDIATION; GENERAL LIABILITY & WORKERS’ COMPENSATION** – La. R.S. 2150–2192, 2186(B)(6), 2189(A)(7) and Rules and Regulations Sec. 1503(D)

Applications Director Elaine Riggins was called to the stand to give testimony regarding the documentation of general liability and workers’ compensation insurance coverage. Ms. Riggins removed the following companies from the agenda: APEX HOMES, LLC; ASSOCIATED CONSTRUCTION GROUP, LLC; DELISE RESTORATION & CLEANING SERVICES, LLC; JAMES T. CREIGHTON; KELVIN A. PAUL and OUTDOOR LIVING POOLS, LLC. Ms. Riggins also confirmed service for the remaining entities listed on the agenda under C. Insurance Hearings.

The following entities listed under C. Insurance Hearings previously had one or more insurance violations. No one was present on behalf of BTSI CONSTRUCTION, LLC and LOUISIANA CABIN COMPANY LLC. Ms. Riggins provided testimony to the board. Mr. Wyman made a motion to revoke the license and/or registration for BTSI CONSTRUCTION, LLC back to the date of last insurance coverage for a period of one year, to issue a cease and desist order, and to assess a \$500 fine plus \$500 in administrative costs. Mr. Hamilton seconded, and the motion passed. Mr. Wyman made a motion to suspend the license/registration back to the date of last insurance coverage, to issue a cease and desist

order, assess \$500 in administrative costs, to allow the company's license/registration to be reissued upon proof of insurance coverage and to allow staff to reinstate the license or registration and rescind the administrative costs if proof of no lapse is provided. Mr. Hamilton second. The motion passed.

Paul Simmons was present on behalf of RIVER OAK CONSTRUCTION LLC and was sworn in. Ms. Riggins provided testimony to the board. Mr. Simmons gave a statement and affirmed that there was a lapse in insurance coverage. Mr. Wyman made a motion to suspend the license/registration back to the date of last insurance coverage, to issue a cease and desist order, assess \$250 fine and \$250 in administrative costs, to allow the company's license/registration to be reissued upon proof of insurance coverage and to allow staff to reinstate the license or registration and rescind the administrative costs if proof of no lapse is provided. Mr. Morse seconded, and the motion passed unanimously.

Judge White read aloud the remaining entities listed under C. Insurance Hearings and asked the entities to make an appearance.

Emerson Anderson was present on behalf of E 3 BUILDERS LLC and was sworn in. Ms. Riggins provided testimony to the board. Mr. Anderson gave a statement and affirmed that there was a lapse in insurance coverage. Mr. Wyman made a motion to suspend the license/registration back to the date of last insurance coverage, to issue a cease and desist order, assess \$250 in administrative costs, to allow the company's license/registration to be reissued upon proof of insurance coverage and to allow staff to reinstate the license or registration and rescind the administrative costs if proof of no lapse is provided. Mr. Morse seconded, and the motion passed unanimously.

Ms. Riggins provided testimony to the board. Mr. Morse made a motion to suspend the license or registration of the aforementioned companies and individuals back to the date of last insurance coverage, to issue a cease and desist order, to assess a \$500 fine plus \$500 in administrative costs, to allow the company's license/registration to be reissued upon proof of insurance coverage and to allow staff to reinstate the license or registration if proof of no lapse is provided. Mr. Hamilton seconded. The motion passed unanimously.

Ms. Riggins provided testimony to the board. Mr. Thaller gave a statement and affirmed that there was a lapse in insurance coverage. Mr. Landreneau questioned Mr. Thaller. Mr. Wyman made a motion to suspend the license/registration back to the date of last insurance coverage, to issue a cease and desist order, assess \$250 in administrative costs, to allow the company's license/registration to be reissued upon proof of insurance coverage and to allow staff to reinstate the license or registration and rescind the administrative costs if proof of no lapse is provided. Mr. Morse seconded, and the motion passed unanimously.

Mr. Wyman made a motion to accept the plea. Mr. Guidry seconded. The motion passed. Mr. Bernard and Mrs. Bernard gave statements to the board. The board questioned Mr. Bernard and Mrs. Bernard. Mr. Wyman made a motion to assess a \$500 fine and \$500 in administrative costs. Mr. Morse seconded. The motion passed with opposition by Mr. Guidry.

Mr. Wyman made a motion to find TIGERSHARK POOL & SPA LLC to be in violation and to assess a \$500 fine plus \$1000 in administrative costs. Mr. Guidry seconded. The motion passed.

Mr. Wyman made a motion to find 4-19 CONSTRUCTION LLC to be in violation, to assess the maximum fine plus \$1000 in administrative costs and to issue a cease and desist order. Mr. Fine seconded. The motion passed.

Shane Normand was present on behalf of NORCO CONSTRUCTION LLC and was sworn in. Marcos Salas was present on behalf of SALAS INTERNATIONAL CONSTRUCTION, LLC and was sworn in. Mr. Normand entered a plea of admission. Mr. Salas entered a no contest plea. Mr. Wyman made a motion to accept the pleas. Mr. Morse seconded. The motion passed. Mr. Norman gave a statement to the board regarding these matters. Mr. Salas gave a statement to the board regarding these matters. Homeowners Janice and William Beard were called to the stand and sworn in. Attorney Jerry Pepper, representing Mr. and Mrs. Beard, addressed the board. Mr. Pepper questioned Mr. Beard and Mrs. Beard. Ms. Hughes reviewed the exhibit packet and provided testimony to the board. Mr. Landreneau entered the exhibit packet into evidence and it was admitted. Mr. Wyman made a motion to find LEADERS AND ASSOCIATES, INC. to be in violation, to assess the maximum fine plus \$1000

in administrative costs and to issue a cease and desist order. Mr. Hamilton seconded. The motion passed.

Mr. Wyman made a motion to assess a \$3000 fine plus \$1000 in administrative costs and to issue a cease and desist order and to allow the fine to be reduced to \$1000 plus \$1000 administrative costs if the company obtains a proper license and/or registration within 120 days. Mr. Morse seconded. The motion passed.

Mr. Wyman made a motion to assess a \$3000 fine plus \$1000 in administrative costs and to issue a cease and desist order and to allow the fine to be reduced to \$1000 plus \$1000 administrative costs if the company obtains a proper license and/or registration within 90 days.
