Mr. Guidry led the Pledge of Allegiance.

Judge Darrell White gave the invocation.

Mr. Wyman made a motion to accept the Minutes of the September 19, 2018, Residential Building Subcommittee Meeting. Mr. Morse seconded. The motion passed.

NEW BUSINESS

Leann Evans with the Compliance Department, Elaine Riggins with the Applications Department and Brad Hassert with the Compliance Department for the board were sworn in.

C. INSURANCE HEARINGS:

RESIDENTIAL BUILDING, HOME IMPROVEMENT, AND MOLD REMEDIATION; GENERAL LIABILITY & WORKERS’ COMPENSATION – La. R.S. 2150–2192, 2186(B)(6), 2189(A)(7) and Rules and Regulations Sec. 1503(D)

Applications Director Elaine Riggins was called to the stand to give testimony regarding the documentation of general liability and workers’ compensation insurance coverage. Ms. Riggins removed the following companies from the agenda: HOLLY CONSTRUCTION, LLC; MECHANICAL CONSTRUCTION COMPANY, L.L.C. and RUSTON PROPERTIES, LLC. Ms. Riggins also confirmed service for the remaining entities listed on the agenda under C. Insurance Hearings.

Judge White read aloud the remaining entities listed under C. Insurance Hearings and asked the entities to make an appearance.

Mr. Guidry seconded, and the motion passed unanimously.

Ms. Riggins stated a representative for BLANDCO, L.L.C. called her to state no one would be able to attend the board hearing. The board questioned Ms. Riggins. Mr. Wyman made a motion to dismiss the case. Mr. Hamilton seconded. The motion passed unanimously.

Sidney Barthelemy was present on behalf of B SQUARED CONSTRUCTION L.L.C. and was sworn in. Ms. Riggins provided testimony to the board. Mr. Landreneau questioned Mr. Barthelemy. The matter was recessed. Mr. Barthelemy provided proof of no lapse in coverage. Mr. Wyman made a motion to dismiss the case. Mr. Temple seconded, and the motion passed unanimously.
