Action: Consent judgment of no finding of fault. The Board ordered Qwest to complete foundation work and present a copy of Certificate of Occupancy

Action: The Board granted the request for rehearing. The Board rescinded its previous decision and reinstated Commercial license #48135

Allegation: Problems relating to the ability of the contractor, its qualifying party, or any of its principal owners or principal shareholders to engage in the business of contracting, as demonstrated by their prior contracting business experience.

Action: The Board waived the 120 day employment requirement for the new qualifying party for Huskey Construction and gave the new applicant until January 31, 2013 to be tested and approved.
